EQUIPMENT

- Children participating in tennis must supply their own tennis rackets. Children in baseball must supply their own baseball gloves. All other equipment will be supplied.
- Everything a child brings to Hedges should be clearly marked with their name (first and last) and telephone #
- Dressing appropriately is very important for this program. Please make sure your child is wearing sneakers to this program. **Flip Flops, sandals and crocs are not safe for a child to be participating in activities, and children will not be permitted to participate in the program with them on.** Be sure to take into consideration heat, chance of rain, sea breeze, etc. A ball cap is also a good idea.
- Please make sure your child comes to Hedges with sunscreen already on. We are not permitted to apply sunscreen onto children.
- **Please check your child for ticks every day. We are in woodsy areas, so there is always the possibility.**



MEDICATIONS / FOOD / BATHROOM FACILITIES

- Supervisors (**Blue Shirt**) **MUST BE** informed of any allergies the child might have or medication he/she is carrying with them (i.e. Epi Pen, pill, or blood sugar device)
- If your child requires an epi pen or inhaler, they must carry it in their backpack everyday they are at the program. Your child will not be permitted to be dropped off without it.
- There will be a snack break between the second and third activity. We encourage all children to bring a snack and non-glass container with a sport drink/water. Please try to make your child's snack peanut/nut free.
- All children must be potty trained/ be able to use bathroom independently.
- Bathroom Facilities are available at Hedges Pond



HALF DAY PLAYGROUND RULES

While we want this to be a fun experience for your child, they must follow the rules.

There is absolutely no swearing, bullying, fighting, or being disrespectful to the staff or other participants allowed at the program. We will notify you if your child gets into trouble, and ask that you talk to your child about the rules. If this becomes a persistent problem, your child will be suspended from the program without a refund.

Sneakers or closed-toe shoes must be worn to camp. Crocs, flip flops, sandals and slides are not safe for a child to be participating in activities, and children will not be permitted to participate in the program with them on.

Children are not permitted to go near the Pond at anytime. If a child goes near the pond without permission they will be suspended from the program for 5 days.

PLEASE MAKE SURE YOUR CHILD BRINGS THE FOLLOWING EVERY DAY TO HEDGES:

- WATER AND SNACK
- WEARING SUNSCREEN AND BUGSPRAY
- WEARING SNEAKERS AND THEIR GROUP SHIRT



DROP OFF & PICK UP

- Children can be dropped off as early as 8:50am. There is NO PARKING during drop-off. **For drop-off and pick up:** drive down the big loop toward the beach (please stay on the dirt path) and circle around to the tennis courts. Our staff will open the doors to help speed up the process.
- If your child is going to be picked up early for any reason, the supervisor **MUST BE** notified in writing. If your child is going to be going home with someone besides a parent/guardian, the supervisor **MUST BE** notified in writing.
- PICK-UP time will begin @ 11:50. **You will not be able to come into the park until then, so please do not come any earlier. We will have the front gate closed to prevent parents from arriving early. You are not permitted to park in front of the closed gate or on the side of the road either.**
- **Please notify everyone on your child's authorized pick-up list that we will have the front gate closed until 11:50. Nobody is permitted to park in front of the closed gate or on the side of the road either.**
- Please note: While we can understand the unexpected emergency, our latest pick-up time is 12:15pm. If your child is not picked up from Hedges by 12:30pm, you will be charged \$15; and every minute after that will be an additional \$1 until your child is picked up. Your fee must be paid within 5 business days of your tardiness. There will be one warning before the fee is imposed. Continued tardiness will result in your child being suspended from the program.

PLEASE NOTE THAT IF YOU STAY WITH YOUR CHILDREN AFTER THE HALF DAY PROGRAM TO USE THE PARK, THE BEACH DOES NOT OPEN UNTIL 12:30 PM, NO ONE WILL BE PERMITTED IN THE WATER UNTIL THEN. PARKING DOES REQUIRE THAT YOU HAVE A BEACH STICKER OR YOU WILL NEED TO PAY THE DAILY PARKING FEE OF \$20. THANK YOU!

PICK-UP POLICY

- ANY INDIVIDUAL THAT IS PICKING UP A CHILD FROM OUR PROGRAM MUST HAVE A PHOTO ID ON THEM AND SHOW IT TO OUR STAFF EVERY DAY.
- We will have an approved pick-up list for your child. Everyone must bring a photo ID if they are picking up a child.
- If someone comes to pick up your child that is not on the approved list and we did not receive a written letter that morning, we will not release your child until we have reached you by phone and get a verbal acknowledgment that you are allowing them to be picked up by this individual. They must then show a photo ID.
- **THERE WILL BE NO EXCEPTIONS TO THIS POLICY, PLEASE BRING YOUR ID EVERY DAY!!**
